The Daman sub-fund's investment objective is to achieve medium to long term capital appreciation with a high correlation to the MENA Region's broader markets including Turkey & Pakistan by investing primarily in securities of issuers listed in the MENA Region or investing in securities of issuers listed outside of the MENA Region but deriving most of their revenues from the MENA Region.

STRATEGY

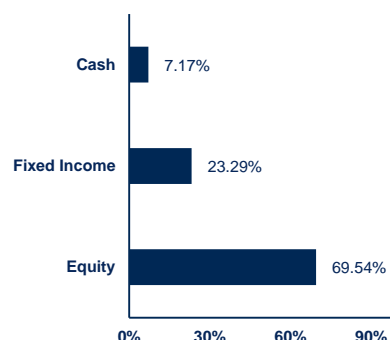
The Daman sub-fund will invest in listed equities, listed equity related securities, including but not limited to American Depositary Receipts (ADRs), Global Depositary Receipts (GDRs), equity swaps and notes and initial public stock offering (IPOs) and debt instruments of issuers located in or deriving a significant portion of their revenues from the MENA Region, including debt instruments rated both as investment grade and below investment grade. The Daman sub-fund may also use financial derivative investment although these will be limited to forwards and financial futures contracts used for hedging and efficient portfolio management purposes.

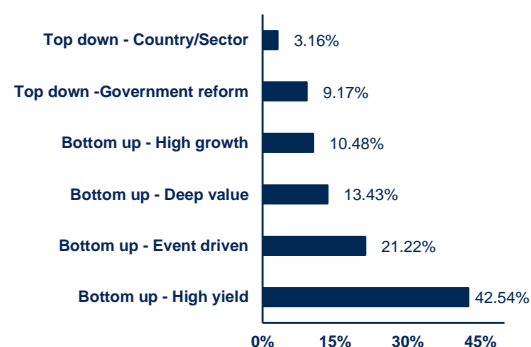
SYNTHETIC RISK & REWARD PROFILE

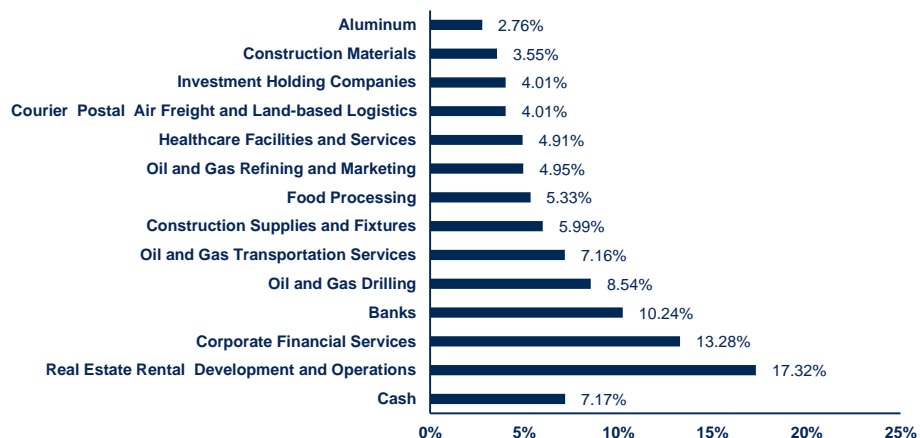
