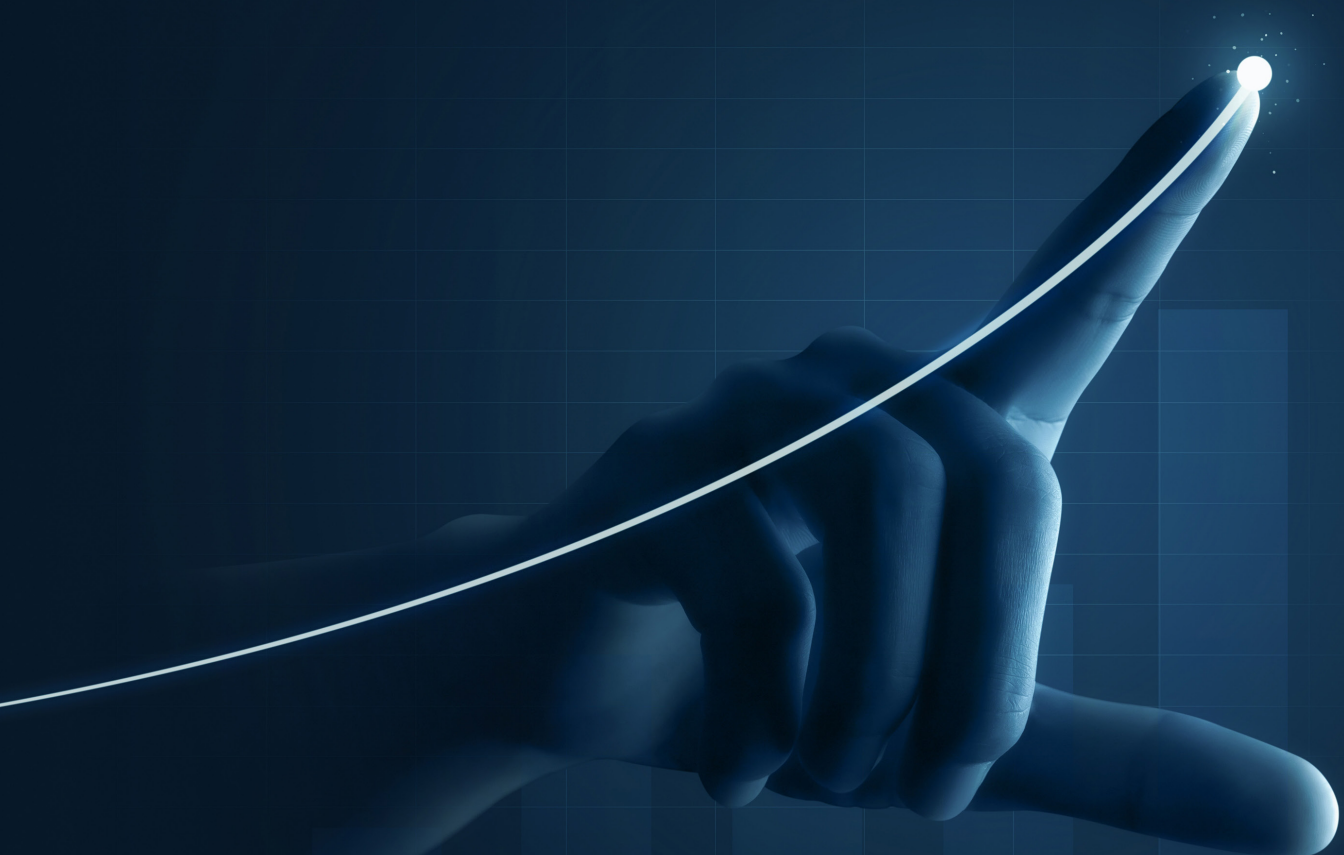

(c) In case a third-party administration services are used the charges will be **USD500** excluding VAT per month per account (portfolio).
